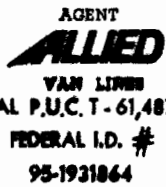

MAXIMUM RATES IMPORTANT NOTICE: No rates higher than the Maximum fixed Rates promulgated in the California Public Utilities Commission's Maximum Rate Tariff 4 may be quoted or charged, unless an Estimated Cost of Services has been issued no less than three (3) days before the day of the move.

COVERAGE FOR LOSS & DAMAGE There are three (3) options available for loss and damage: 1. 60 cents per pound per article. 2. Actual Cash Value. 3. Full Value Protection.

NOTICE: Coverage for loss and damage is limited to the Actual Cash Value of losses up to the amount of \$20,000 unless the Shipper signing this Agreement inserts in the space provided other than 60 cents per pound per article.
