STATEMENT OF CUSTOMER RESPONSIBILITIES

Typical household items of extraordinary value are: Antiques, China, Crystal, Figurines, Furs, Objects of Art, Oriental Rugs and Sterling Silverware, but other items may also fall into this category and must be identified as well.

This High Value Inventory is to be completed and signed by the customer and **returned to the agent representative prior to any packing or loading of the shipment.**

Failure to list items of extraordinary value will limit the carrier's liability for loss or damage to \$100 per pound based on the actual weight of the article, not to exceed the total declared value of the shipment. **If your shipment does not have any items of extraordinary value, sign the following statement.**
